Batting Cage Rental Rules

1. Batting Cages may be rented Monday through Friday during the times of 7-10pm and Saturday through Sunday during the times of 3-6pm. After hour rentals may be available per request.
2. Only one request allowed per application.
3. The entire rental fee must accompany the application.
4. Applications are processed within seven days of receiving application. Renters are notified in writing of confirmation or denial. A copy of the contract and a receipt will be sent when the reservation is confirmed.
5. Additional charges for damages and/or improper cleanup will be the renter's responsibility.
6. **Cancellation Policy:** Saline Parks & Recreation reserves the right to cancel a rental at any time due to facility issues. A full refund will be issued in this situation. Cancellation by renter must be submitted seven days prior to rental date for a full refund (minus \$10 administration fee). Less than seven days' notice will result in forfeiting ½ of rental fee. Less than 24 hours notification results in loss of all rental fees.
7. When reserving batting cages, please specify the hours using the batting cages. The batting cages is reserved for that time only. Other rental groups may have reserved the batting cages earlier/later in the day.
8. SRC is not responsible for any injuries incurred while using this facility.
9. All batters must wear helmets at all times while in cages. This includes batting practice and soft toss. Adult coaches within the cages must remain behind protective 'L' screens during live pitching. Catchers in the cage will wear full protective gear.
10. Only one batter is allowed in a cage at any time.
11. Closed-toe shoes must be worn at all times. No baseball/softball cleats allowed.
12. No practice swings or swinging of bats allowed outside the cages at any time. This includes hitting 'soft toss' outside the nets.
13. All individuals outside of the batting cage must remain 3'-0" back from suspended netting at all times.
14. No hitting balls against facility walls.
15. No playing catch anywhere outside cage.
16. Protective netting shall never be pulled back in any way.
17. Please assure that all balls are picked up and placed in their proper containers.
18. Leave the cage clean the next scheduled team.
19. The use of any cage by teams or individuals must be scheduled by SRC, prior to use.
20. Absolutely no unauthorized persons shall enter the cage area.
